#### CATEGORISATION OF CANDIDATES:

The candidates appearing for Intermediate (TOSS) Public Examinations are categorized as follows:

CATEGORY-1: Candidates admitted online during 2021-22 (i.e., fresh admissions of the academic year) are treated as Category-1.

CATEGORY-2: Candidates admitted during previous years i.e., 2016-17, 2017-18, 2018-19, 2019-20 & 2020-2021 and appeared for Intermediate (TOSS) Public Examinations but failed are treated as Category-2.

CATEGORY-3: candidates admitted during previous academic years i.e., 2016-17, 2017-18, 2018-19, 2019-20 & 2020-2021 and appearing for the Intermediate (TOSS) Public Examinations for the first time are treated as Category-3

CATEGORY-4: Candidates admitted during the academic year 2021-22 (fresh admissions of this academic year) but having only one year gap after passing SSC and are eligible to appear to a maximum of 4 subjects only, are treated as Category-4.

CATEGORY-5: Candidates who have appeared for Intermediate (TOSS) Public Examinations and passed in some subjects and failed in some subjects and desires to improve their performance in any passed subjects are treated as Categroy-5.

CATEGORY-6: Candidates who have passed (all subjects) Intermediate (TOSS) Public Examinations and desires to improve his performance by cancelling his previous performance. The latest performance holds good either pass or

fail. The original pass certificate and Migration cum Transfer Certificate of TOSS shall be surrendered to TOSS along with under taking of the candidate.

CATEGROY-7: Failed candidates of Categroy-5 who have already availed the improvement chance. And not allowed to avail improvement chance in future.

CATEGORY-8: Failed in 6<sup>th</sup> subject (addl. subject) and Passed in all the main five subjects and pass certificate also issued to the candidates. These candidates appearing only for the 6<sup>th</sup> subject. The main five subject codes are kept blank.

ALL THE AI-COORDINATORS ARE REQUESTED TO NOTE THAT, **ONLINE ENRS WILL BE HOSTED IN THE WEBSITE**. All the AI Coordinators are requested to instruct the candidates to approach **TS Online /Meeseva centres in Telangana State** for payment of examination fee.

An asterisk (\*) mark on the subject code denotes that the candidate already passed in that subject and no need to appear for the examination. Subject codes without Asterisk Mark, indicates failed subjects. The provision of selection of subjects (to appear for the examination) is given to the subjects in which the candidate failed only. Total number of failed papers is indicated under the heading SUB.CNT (subject count).

### **TOC CANDIDATES:**

- ii. Fail or pass in the 6<sup>th</sup> Additional subject shall have no impact on the chosen five subjects pass.
- iii. If the candidate fails in any one subject of the chosen five subjects, the result will be declared as failed, irrespective of his pass in 6<sup>th</sup> additional subject.

### **IMPROVEMENT OF PERFORMANCE:**

There is **no provision of improvement** to the candidates who have **passed in all the subjects**. If any candidate wants to improve his performance, **he can do so by duly cancelling the earlier performance**. In such case the marks in the

latest performance only holds good either passed/improved/failed. Such candidate has to submit the following apart paying examination fee for all subjects including practical papers if any. Without submitting the following they are not eligible to pay the examination fee.

- f.   - iv. Payment of examination fee.(Examination fee @Rs.250/- per theory paper and @ Rs.200/- per practical paper) in the form of DD payable to the Director TOSS, Hyderabad should be submitted.
